



Factsheet GlobalStars – India

Commissioned by the Ministry of Economic Affairs and Climate

India and The Netherlands, together with Belgium (Flanders Region), Spain and United Kingdom have announced the GlobalStars call for joint R&D projects in the field of “One Health”. Applicants are invited to submit joint project proposals for collaborative industry-led R&D projects aimed at creating innovative products, processes and services in this focus area. Deadline for submission of the proposals is **October 1, 2018 at 17:00 CET**.

The Indian national authority is the Department of Biotechnology (DBT) of the Ministry of Science & Technology. DBT and Netherlands Enterprise Agency will provide access to public funding for joint projects, in accordance with national funding rules. The call is managed using the EUREKA platform for trans-borders innovation.

The project partners should include at least one Dutch company and one Indian organisation. Dutch research organisations can participate as partner. Organisations from Belgium, Spain and United Kingdom may also participate. They can be funded by their national funding body and according to their own national regulation.

Special focus

This call invites projects in the field of “**One Health**”: Affordable, innovative solutions for prevention and control, point of care diagnostics and treatment of infectious and chronic diseases, to improve prevention, treatment outcomes and efficient utilization of health resources.

Timelines

- Opening of the call: July 16, 2018
- Project building and matchmaking activities: end of August, 2018 (TBC)
- Call deadline: October 1, 2018 at 17:00 CET
- Evaluation meeting: December 7, 2018
- Funding decision and project start: before April 1, 2019

Funding

There is no minimum or maximum in eligible project costs. The maximum funding per project for all Dutch project partners involved is € 350,000. The amount of funding depends on the type of activity and the type of organisation. See table for the subsidy percentages used in The Netherlands.

In the Netherlands a total of € 935,000 is available for grants for this GlobalStars call.

The application consists of an international part: EUREKA Project Form, Annex and Signature Forms sent to EUREKA office in Brussels, and a national part: a Dutch application form and annexes sent to Netherlands Enterprise Agency.
