



Factsheet EUREKA COVID-19 Network Call Solutions for COVID-19 Echo Period "Life without a vaccine"

The Netherlands, together with Austria, Canada, Denmark, France, Spain and Turkey have announced EUKERA Network Call for Proposals "Solutions for COVID-19 Echo Period, "Life without a vaccine". Opening of the call: **April 15, 2020.** Deadline for submission of the proposals is **May 15, 2020 at 17:00 (CEST)**.

Health~Holland, in cooperation with Netherlands Enterprise Agency, will provide access to public funding for the Dutch participants in joint projects, in accordance with national PPP allowance funding rules. Participants from above mentioned EUREKA countries will be funded by their national funding body in accordance with their national funding rules. Organisations from other countries can participate, but these parties have to secure their own funding within the deadlines for this call. The call is managed using the EUREKA platform for cross-border innovation.

The project consortium should include at least one organisation from the Netherlands and one organisation from a participating EUREKA country. Additionally, the consortium should consist of at least one for-profit enterprise and at least one research organisation. The project duration may not exceed 12 months.

- Opening of the call: April 15, 2020

- Call deadline: May 15, 2020 at 17:00 (CEST)

funding decision: before June 30, 2020
Project start before August 3, 2020

Scope

Applicants are invited to submit proposals for collaborative R&D Life Sciences & Health projects aiming to provide **short to medium-term responses to COVID-19 specific needs**. These can include (but not limited to):

- Infection prevention and protection
- Sanitation technology
- Diagnostics and testing
- Therapeutics, vaccines and medicines
- Disease-tracking technology
- Smart technology for COVID-19 patients

If your consortium and project matches the criteria, please submit your application before May 15, 2020, 17.00 hours (CEST). Please note! The application consists of: 1. international part online EUREKA Project Form available via the call webpage on the EUREKA website, and 2. national part - Dutch application form and annexes sent to Netherlands Enterprise Agency, and where relevant, a national application sent to national funding body of project partner(s).

Funding

There is no minimum or maximum in eligible project costs. The maximum funding per project for Dutch project partners involved is € 100,000. The amount of funding depends on the type of activity (industrial research or experimental development). See table for the subsidy percentages used in The Netherlands.

In the Netherlands a total of € 500.000 is available for grants for this EUREKA Network Call 'Life without a vaccine'.

After project evaluation and ranking advise by Netherlands Enterprise Agency, Health~Holland takes the final funding decision, funds and further manages the approved projects.
