



# Factsheet GlobalStars Singapore (2020)

*Commissioned by the Ministry of Economic Affairs and Climate Policy*

**Singapore and The Netherlands, together with Austria, Belgium (Flanders Region), Canada, Estonia, Poland, South Africa, South Korea, Spain, Switzerland, Turkey and the UK have announced a GlobalStars call for joint R&D projects on all thematic areas.**

Applicants are invited to submit proposals for collaborative industry-led R&D projects in any technological field addressing a societal challenge or need, leading to innovative, affordable and marketable solutions. Deadline for submission of the proposals is **15 October 2020 at 17:00 CET**.

Entreprise Singapore and the Netherlands Enterprise Agency will provide access to public funding for joint projects, in accordance with national funding rules. The call is managed using the EUREKA platform for trans-borders innovation.

The project consortium should include at least one Dutch company and one company from Singapore. Dutch research organisations can participate as partner. Organisations from Austria, Belgium (Flanders Region), Canada, Estonia, Poland, South Africa, South Korea, Spain, Switzerland, Turkey and the UK may also participate as partner.

They can be funded by their national funding body and according to their own national regulation. Organisations from other countries can participate, but these partners have to secure their own funding within the deadlines for this call.

## Special focus

This call invites collaborative research and innovation projects in all thematic areas. The Netherlands in particular welcomes collaborative projects in the fields of:

- Digital technologies
- Circular economy
- Climate adaptation
- Agrifood technologies.

## Timelines

- Opening of the call: 8 June 2020
- Project building and matchmaking activities: June/July 2020 (TBC)
- Call deadline: 15 October 2020, 17:00 CET
- Evaluation meeting: December 2020/January 2021 (TBC)
- Funding decision and project start: February/March 2021

## Funding

There is no minimum or maximum in eligible project costs. The maximum funding per project for all Dutch project partners involved is € 350,000. The amount of funding depends on the type of activity and the type of organisation. See table for the subsidy percentages used in The Netherlands

In the Netherlands a total of € 925,000 is available for grants for this GlobalStars call.

The application consists of an international part: the online EUREKA Project application, and a national part: a Dutch application form and annexes sent to Netherlands Enterprise Agency.
